For the total sum of _____ the Seller agrees to sell, and the Buyer agrees to purchase the puppy described below.

Seller agrees to provide Buyer with the necessary paperwork to register Puppy in the American Kennel Club with **Limited Registration**. If applicable, Seller will also provide ASCA Registration papers (Not For Breeding).

Limited Registration Terms:

- Buyer agrees to spay/neuter puppy by 24 months of age and provide Seller with proof of spay/neuter. Should Buyer want to leave the puppy intact (without breeding the puppy) for health reasons, Buyer must receive written approval from Seller before the puppy is 24 months old.
- Buyer agrees NOT to breed this puppy. If Buyer chooses to breed this puppy, Buyer will be subject to a penalty of \$5000 per litter to be paid to Seller. In addition, Buyer must provide Seller of proof of spay/neuter of puppy within 30 days from notice from Seller or Buyer shall be required to surrender puppy and registration papers to the Seller who will claim full and sole ownership of the puppy.

Buyer agrees to NEVER register this puppy as any other breed.

Buyer agrees not to register this puppy with any other registries and will ONLY register this puppy with AKC, ASCA, and/or UKC (as applicable) as an Australian Shepherd.

Abundant Life Ranch (ALR) shall be the ONLY kennel name represented on the registration papers for the The American Kennel Club (AKC) and the Australian Shepherd Club of America (ASCA). Buyer agrees that the puppy's registered name shall begin with ALR. (Example: ALR Touch The Sky)

While we do our best to give an educated guess, Seller does not guarantee eye color, ear set, or size of the puppy.

Buyer agrees to keep the puppy in good health, appropriate vet care, provide proper deworming, to provide clean water, a healthy nutritious food, and exercise.

To the best of seller's knowledge, this puppy is in good health. If desired, Buyer has 72 hours, from pick up of puppy, to have the puppy examined by a licensed veterinarian. If there is a problem that cannot be resolved, Buyer can return the puppy (and registration paperwork), at Buyer's expense, the following day along with a statement from the veterinarian stating the problem. Buyer will receive a full refund of the purchase price of the puppy less the deposit made and any transportation fees. Buyer assumes sole responsibility for veterinary expenses and transportation costs once puppy leaves Seller's possession.

This guarantee does not cover the presence of parasites, umbilical hernias, seizures (from MDR1 sensitive drugs in any form), or problems from an accident or injury. This guarantee also does not include common and easily treatable things like viral and bacterial infections such as coccidia and giardia (forms of parasites) and kennel cough (a raspy cough similar to a common cold that simply needs to run its course). Bringing a puppy to a new environment can put a lot of stress on a young puppy's immature immune system which can naturally make them susceptible to common illnesses and parasites. Puppies were regularly treated for parasites while in Seller's possession and Buyer will need to continue a regular parasite prevention program for puppy's lifetime.

Buyer agrees to not to give the puppy any Ivermectin or any MDR1 sensitive drugs in any form for any reason. Simply verify the veterinarian is aware and using alternative drugs which are readily available.

Buyer understands that the puppies are not vaccinated before leaving Seller's possession. Vaccination is not a black and white issue - there are pros and cons to both vaccinating and to not vaccinating. Seller believes in allowing the Buyer to choose whether they wish to pursue holistic or allopathic health care for their puppy. Buyer assumes all responsibility of health decisions for the puppy upon leaving Seller's premise. Because vaccines shed and can weaken immune systems, which can lead to the puppy getting the very disease they are being vaccinated for, (Example: up to date vaccinated litters dying from parvo) if Buyer chooses to have puppy vaccinated, Buyer assumes all responsibility for any outcome for the puppy even if it is within the 72 hours health guarantee.

Buyer agrees that puppy appears to be in good health at time of purchase. Buyer's Initials _____

If for any reason during the Puppy's lifetime, the Buyer must rehome the Puppy, the Buyer must inform Seller of the need to rehome. Seller reserves the first right of refusal and Buyer must receive written approval to rehome puppy. Seller may offer to take back the Puppy or assist in finding the Puppy an approved new home to prevent the puppy ending up in a shelter or euthanized. Seller will not refund the purchase price or provide a replacement puppy unless the puppy's return was due to misrepresentation on the part of the Seller. If puppy is Limited Registration, puppy MUST be spayed/neutered and Buyer must provide proof to Seller before rehoming. Buyer agrees not to sell this puppy (nor puppies born from this dog) to brokers/pet stores, known puppy mills, wholesale outlets, dealer, guard dog business, or research facility.

If any of the above agreements are broken at any time buyer is responsible for a \$5000 penalty for each occurrence. If the puppy is neglected or abused at any time in its life the seller can regain full ownership.

ALR reserves the right to refuse to place a puppy for any reason at any time up until puppy leaves ALR possession.

This agreement represents the entire agreement between the Seller and Buyer. No other agreements, promises, representations, or warranties, express or implied, are applicable unless specifically stated in this agreement. Any dispute of this contract shall take place in the Seller's county court.
